The Daniel Island Community Association (DICA) operates the pools on the south end of Daniel Island. At these facilities, we strive to provide a safe and clean environment. Please note, lifeguards and/or gate attendants may not be scheduled during your party (check with the POA staff for schedules). On occasion, large groups arrive at the pool without the association's prior knowledge. When this occurs, it creates potential safety hazards due to the number of swimmers in the pool. For this reason, the association has enacted policies governing pool parties. Anyone who wishes to have a party at Scott should complete this application in order to properly register with the association and ensure tables will be held for the event. Please note, we do not hold pool parties at the Pierce Park or Edgefield Park Pools.

Fee Schedule:

A non-refundable fee of \$50.00 will be applied to all parties for the rental of the picnic tables at Scott Park. An additional non-refundable \$25 fee will be added for every hour past the initial 2 hours – please check with POA staff before extending your party to ensure there is not another party scheduled.

Rental Agreement – please initial next to each term below

1. A resident must make arrangements through the Property Owners Association in order to schedule a pool party.
2. Pool parties may be scheduled at Scott Park Pool Monday-Sunday from 10:00AM - 12:00 PM or 2:00 PM - 4:00 PM. Certain dates and times may not be available, and parties are scheduled based on the peak times of pool usage and events taking place at pools. All parties must be limited to 2 hours. If you would like to extend your pool party time, must have approval by POA prior to dropping off paperwork. \$25 will be charged for each additional hour.
3. Applicant and those attending will be held responsible for following all DICA pool rules and DHEC pool rules.
4. Party will be scheduled based on the availability of the pool.
5. In the event of inclement weather on the date of the party, the event may be rescheduled subject to availability of the pool. If you do not want to reschedule, no refund will be given.
6. Event cancellations unrelated to weather should be made in writing at least 1 week prior to the event. Party fees are non-refundable at any time.
7. Outside lifeguards cannot be brought in to supervise your event. These lifeguards are not protected by DICA's Insurance and Liability Policies.
8. The pool rental agreement does not include exclusive use of the pool.
9. Jump castles or other inflatables, animals, etc. are not permitted at pool parties.
10. Residents and pool party guests agree to swim at their own risk as no lifeguard will be on duty.
11. Parties are confirmed once contract is signed, payment is made, and confirmation from the Property Owners Office is given.
